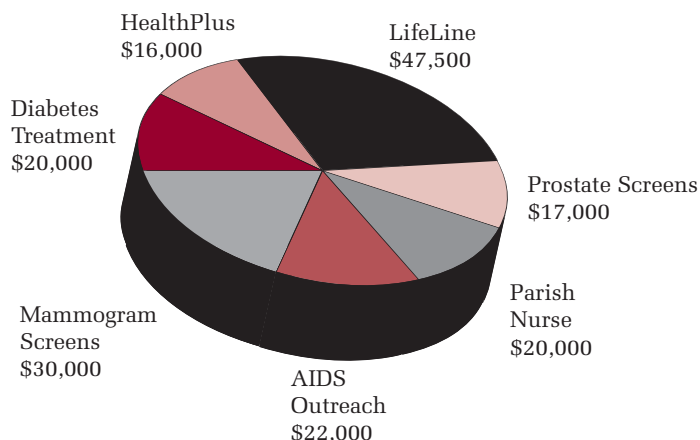

How Gifts That Support Foundation Grants Will Be Spent in 2007-08

We are inspired by the commitment from the community to the East Alabama Medical Center Foundation. Contributions that go where the need is greatest allow the Foundation to provide financial assistance for community health care programs. The East Alabama Medical Center Foundation will award grants this month totaling \$172,500 (highlighted below) for fiscal year 2007-08.

- EAMC Parish Nurse Program—integrates faith and health. Parish nurses are employed by EAMC and are members of the churches they serve.
- AIDS Outreach of EAMC—devotes resources to HIV prevention, education, housing and direct services to people living with HIV/AIDS in Lee, Chambers, Russell, Tallapoosa and Macon counties.
- Mammogram Screens for Underserved Women—subsidizes the cost of mammogram screenings and any required follow-up testing.
- Diabetes Treatment Center—provides 24 scholarships (full or partial) to those in need of diabetes education, as well as supplies for ongoing evaluation and self-management.
- HealthPlus Fitness Center—gives scholarships to patients with medical conditions that would benefit from fitness programs. Applicants must be under an EAMC physician's care and receive a recommendation. Thirty-four scholarships are currently in use.
- LifeLine Emergency Response System—offers scholarships for LifeLine units that provide clients with the equipment to contact help in emergency situations. This allows seniors to live safely and securely in their own homes. Fifty scholarships are currently provided, with more on the waiting list.
- Prostate Screens for Underserved Men—subsidizes the cost of prostate screenings and any required follow-up tests.

Discover the Tax Benefits Of Year-End Giving

Do you have additional income this year, perhaps from an extra bonus or from selling some investments? If so, your tax planner may advise you to do some charitable tax planning before year-end to lower your taxable income. Please consider the East Alabama Medical Center Foundation when evaluating your options.

To reduce your taxable income this year, consider making a cash gift. Cash gifts are deductible up to 50 percent of your adjusted gross income. Gifts can be directed to a specific need—we'd be happy to provide details—or contributed to our general budget.

Another simple charitable gift to make before year-end is a gift of appreciated stock. Maybe you have stock you were contemplating selling, but you just haven't had the time to sell it. If so, instead of selling the stock and incurring potential capital gain income, give the stock to us. The value of the stock is deductible in the year of the gift to the extent that the stock's value doesn't

exceed 30 percent of your adjusted gross income. Any excess deduction can be used in the next five years.

Alternatively, you might consider making a "planned" gift before year-end. Planned gifts can provide you with lifetime income and improve your tax situation. Planned gifts, however, are generally not as fully deductible as direct gifts, so depending on the amount of your tax deductions and income needs, you may prefer to make a direct gift.

Be sure to have the gift finalized and postmarked by midnight on Dec. 31 to count against this year's taxable income. If you prefer to make a gift with a credit card, you can deduct the gift in the year the charge is incurred—even if the bill is not paid until the following year. For planned gifts, be sure to have all the documents signed and implemented by the end of the year.
